Part 1 Terms and Conditions

The following charges apply in relation to the provision of Services at Royal Seaforth Container Terminal ("the Terminal") by 'The Mersey Docks and Harbour Company (RSCT) Limited' ("the Terminal Operator").

Services provide in relation to Section A of Part 2 (Ancillary Services) and Part 3 (Other Miscellaneous Charges) shall be undertaken in accordance with and subject to the "Standard Terms and Conditions for Container Terminals Operated by Members of the Peel Ports Group" as amended from time to time ("the Standard Container Handling Terms"), unless otherwise agreed or varied in advance by the Terminal Operator.

Services provided in relation to Section B of Part 2 (Container and Equipment Repair Services) shall be undertaken in accordance with and subject to the "Port of Liverpool Container Services General Terms and Conditions in respect of Container and Equipment Repair Services Operated out of Royal Seaforth Container Terminal, Port Of Liverpool", as Amended from time to time ("the Standard Terms for Container and Equipment Repair Services"), unless otherwise agreed or varied in advance by the Terminal Operator.

All operations shall be performed or provided during the normal working hours of the Terminal, details of which can be found in the Standard Container Handling Terms or the Standard Terms for Container and Equipment Repair Services (as applicable). Such normal working hours may be subject to change from time to time.

Additional charges shall be levied for Services performed outside normal working hours and/or at weekends or Bank Holidays or Super Bank Holidays, and subject to such other applicable restrictions or conditions.

The charges herein are subject to alteration at any time.

Except where specified herein to the contrary, all charges payable hereunder shall be payable on demand unless otherwise agreed by the Terminal Operator.

All charges stated are exclusive of Value Added Tax. Value Added Tax (or any other tax required to be levied on the Terminal Operator's charges) shall be payable where applicable at the appropriate rate current from time to time on and in addition to the charges specified or referred to herein. The Terminal operator's VAT registration number is GB 618 6241 39.

Part 2 Ancillary Services and Container and Equipment Repair Services

The following charges apply in relation to the provision of container repair operations and the provisions of other ancillary services at the Terminal.

2.1 Services

Services that may be carried out by the Terminal include:

- Lift in/Lift out of containers.
- Daily Storage of containers (subject to availability of appropriate container storage space at the Terminal).
- Sweep Out of containers.
- Dunnage Removal (including waste disposal) from containers.
- Steam Clean/Wash of containers.
- Transfer Fee (Extra moves to/from Quay Stock of containers.
- Temporary Repair (patching of hole) of containers).

Full container repairs are not a service provided by the Terminal Operator. Such services may be obtained from independent contractors at the Terminal (at a charge payable direct to them).
